Privacy policy

Welcome to the website of our dental practice. The following privacy policy applies to the use of our website and the services offered on it. This privacy policy informs you about the collection of personal data during your visit to this website.

The collection and processing of your personal data is carried out in compliance with the applicable data protection laws and requirements.

In principle, our dental practice only offers its services in Switzerland and is only aimed at persons resident in Switzerland.

Collection of general data and information

Each time the website is called up, a series of general data and information is collected. This general data and information is stored in the server's log files. The following data may be collected: (1) the browser types and versions used, (2) the operating system used by the accessing system, (3) the website from which an accessing system accesses our website (socalled referrer), (4) the sub-websites that are accessed via an accessing system on our website, (5) the date and time of an access to the website, (6) an Internet protocol address (IP address), (7) the Internet service provider of the accessing system and (8) other similar data and information that serve to avert danger in the event of attacks on our IT infrastructure.

This data and information is needed to (1) display the content of our website correctly, (2) optimise the content of our website, (3) ensure the long-term functionality of our IT infrastructure and the technology of our website, and (4) provide the necessary information to law enforcement authorities in the event of a cyber attack.

Furthermore, our dental practice can evaluate this data and information on the one hand statistically and on the other hand with the aim of increasing the data protection and data security of its IT infrastructure. The collected data and information are only processed for the purposes just mentioned and are subsequently deleted.
